Compliance 101-Don't Wait for the Fine

Part 3 - "The top five most cited safety violations in the precast industry" by Sam Lines, OPCA Technical Consultant and Engineering Manager for Concrete Sealants.

According to the statistics from the Department of Labor, in 2016, there were 526 citations issued under the NAICS Code 3273: cement and concrete product manufacturing. The total amount in fines levied was \$1.03 million. In this part of the series, *Don't wait for the fine,* we will highlight the top five cited regulations in our industry. With 61 citations, Respiratory Protection (1910.134) is number one. Silicosis is a serious disease that affects the lungs. It is caused by breathing dust that contains respirable silica or silica quartz. Where concentrations of dust exceed the permissible exposure limit, action is required. Cutting and grinding concrete is a major source of dust containing silica. Controls such as the use of water to limit airborne dust, and protective *(Continued on p.2)*

Other topics this year will include updates from NPCA's Evan Gurley on crane operator certification, the new tax law implications, and he will join a discussion on Supplement 1073 with ODOT representative Dan Miller; Sam Lines will

present "Mix Design," then facilitate a panel discussion, "Troubleshooting Your Admix"

with Mike McKown (Premiere Admixtures), Gary Nielsen (Sika Corp.), and Shawn Kalyn (St. Marys Cement); a representative of PUCO will present "Legal Truck Loading;" and the IT security company SOPHOS rep will speak about a dramatic increase in Malware entering computers, networks, smartphones, and cloud storage--and ways to protect those valuable, virtual information assets. Of course, exhibitors are always a major highlight of our event, as well.

equipment such as a respirator may be necessary. All manufacturers are required to assess the hazards of the workplace. Fines in this area totaled \$61,354.

Coming in at number two is Hazard Communication (1910.1200) with 56 citations. This regulation had the

highest level of fines levied at \$100,661. Employees have a right to know about the chemicals they are exposed to. Safety Data Sheets are required to be present for all chemicals used in the workplace. Also, employees are to be trained in understanding SDS's and container labels to know the hazards associated with each product.

Number three, with 34 citations is

Powered industrial trucks (1910.178). Forklifts in the precast industry are huge and deadly. OSHA fined our industry \$74,402 for the failure to comply with this rule. All operators of powered industrial trucks must be trained and evaluated by the company. Reevaluation is required at least every three years.

Number four is the Control of Hazardous Energy, or

### Call for OPCA Board of Trustee Nominations!

Lockout/Tagout (1910.147). There were 32 citations of this regulation. This is a common top-five cited violation in all General Industry. OSHA levied a total of \$74,281 in citations. Equipment must be deenergized by an authorized person before maintenance and cleaning operations can take place. To be authorized, the person must be trained, the process must be documented, and the process must

be evaluated annually by a competent person.

Rounding out the top five with 27 citations is Ladders (1910.23). This is related to the requirements for Walking and Working Surfaces in General Industry. The fines for this were the second highest at \$81,993. Walking and working surfaces is typically the second leading cause of fatalities in the workplace behind traffic deaths.

On January 17, 2017, a revised standard for walking and working surfaces became law. This standard will likely continue to be one of the top cited regulations in the precast concrete industry.

In the final part of this series, we will review the remainder of the top ten most cited OSHA standards in the precast industry.

# Safety News & Updates

- The OSHA 300A Summary of Work Related Illnesses and Injuries must be posted from February 1 thru April 30 each year.
- Appeals Court Dismisses Challenges to OSHA Silica Exposure Rule. Compliance Date for Manufacturers is June 23, 2018

The U.S. Court of Appeals for the D.C. Circuit rejected all challenges to OSHA's new silica standard in a unanimous ruling issued Dec. 22, 2017. The ruling means that manufacturers are required to comply with the rule as of June 23, 2018.

OSHA's new silica standards lower the permissible exposure limit to 50 micrograms per cubic meter, which is half of the previous standard. NPCA had joined with the American Chemistry Council and many other industry groups to challenge the ruling, but the judges rejected all claims in the unsigned opinion. The opinion noted that the science is uncertain, but it repeatedly emphasized that OSHA's decision is reasonable, according to an article in The National Law Review.

#### Additional Crane Operator Certification Classes offered at Mid-America OSHA Education Center in Springboro.

Due to high demand, MAOEC has added two more class sessions: February 19-23 (only 2 slots left) and April 16-20, 2018. Each class is limited to 9 candidates. MAOEC will continue to add more sessions as demand dictates. Cost is \$1,500 for the full-week class, regardless of the number of written and practical tests needed.
