### Remembering Roland Lindsay

Industry pioneer and longtime OPCA member Roland Lindsay passed away on August 13, 2020, at the age of 87. A lifelong resident of Canal Fulton, Ohio, Lindsay was a veteran of the Korean War having served in the United States Army. He returned home from service and started Lindsay Excavating and Concrete Products

Company, purchasing his first backhoe and using a hand concrete mixer in his garage to produce his first products.

Executive Director Toni Thompson recalled, "Two years ago, I had the privilege to meet and interview Roland for our video 'Celebrating OPCA--Then & Now.' He said in the very early days of his business nearly 60 years ago, he installed tanks made by other manufacturers; but he was not at all satisfied with their quality, so he decided to make his own." Of course, the rest is a wonderful history of quality, innovation, and growth--and it's

his lasting legacy. Lindsay was a founding member of NPCA, which began in Dayton, Ohio. He served as their Board chairman in 1988.

He is survived by his wife of 60 years, Linda, and children, Melanie (Randy) Lindsay-Brisbin, Roland (Sonya) Lindsay Jr., and Heather (Michael) Hoffman.

He was the proud grandpa of Jenna (Jacob) Mathews; Luke (Taylor) Brisbin; Sarah and Sam Lindsay; and Grace, Alex, and Ellie Hoffman. He is also survived by his sister, Delores (Lindsay) Schweitzer, and many beloved brothers-in-law and sisters-in-law, nieces and nephews.

Dean Wolosiansky of Lindsay Precast in Canal Fulton (OH) and President of the OPCA Board of Trustees shares his insights.

In the precast industry, our companies have to deal with multiple changes each day from outside influences, and most of the time they are totally out of our control. We are resilient, persevering, flexible and try to keep a positive outlook during these daily changes/challenges. COVID has definitely pushed the limit to keep our industry and society resilient, and flexible; but what keeps our companies moving forward is the

determination and positive attitudes. The one thing we all can take ownership in during some challenging times is to focus on what we can control and to pull together and help each other out. The ever changing mandates, legislation and litigation taking place can overwhelm the best of us but we can help learn from one another and

The OPCA Board of Trustees voted unanimously to appoint Dominic Dowell to the position of Trustee At-Large. He is currently the Customer Service Engineer and a Sales Representative for Jet Inc., an Associate Member of OPCA. With over 20 years of precast concrete and wastewater treatment experience, Dowell has installed Aerobic systems along with various pumps and panels, with specific

expertise in equipment, troubleshooting, and specifying panels. He facilitates classroom seminars and field training based on utilizing Jet products for advanced onsite treatment systems. He conducts NSF inspections of licensed Jet distributors' installations and is a member of the Ohio Onsite Wastewater Association (OOWA).

Dowell is serving the unexpired term of the late Justin Setser, who passed in March. He is eligible for election to a full, two-year term when members vote later this year.

### Meet ConSeal's Summer Intern, Ian Underburger

Longtime OPCA Associate member, Concrete Sealants hosted an NPCA Foundation Scholarship Intern this summer. Ian Underburger, of Englewood, Ohio, is a sophomore at The Ohio State University majoring in Civil Engineering. Sam Lines, ConSeal Engineering Manager, and OPCA Technical Consultant is Underburger's mentor.

When asked what he likes best about his experience this summer, Underburger replied, "Having creative management over my own projects." He explained, "Sam will give me a project to work on with directions, and at that point, I take it into my own hands and try to give him the result he's looking for. I like having control in what I'm doing."

According to Lines, "lan has done a fantastic job; in fact, he may have ruined us for future interns. We have offered to have him come back for as many summers as he has! He's very

disciplined, responsible, independent, requires little to no management oversight; he brings the results."

Underburger shared an example of his work project activity. "One of the most fun things I've done here is create a standard control concrete recipe for admixture testing, getting into the concrete mix designs and applying the knowledge I learned through the PQS-I Class into this real-world application." He added, "It's something that can be used in the company when I'm not here next semester. Having my work play into something can be huge."

Sam's advice to the Industry in Ohio: "Don't miss the opportunity to bring on an intern, give them challenging tasks, and let them run with those tasks. You might learn something from the experience; you will also provide the student with a life-long learning opportunity." He explained further, "If you are an associate or producer company, it's definitely worth taking a chance and bringing somebody on board, whether the intern is coming through the NPCA Foundation or some other organization."

Lines also clarified that any internship should be a true learning and mentorship opportunity--not just a means to bring in a laborer. "What people need is someone with an education *and* practical skills," he said. "You get the practical skills either through applied knowledge in an office or manufacturing-factory environment, and the internship is the absolute perfect way to provide those direct, applicable skills that are needed to be successful in the workforce." He concluded, "We're talking about gaining the skills and knowledge so that not only can the intern say they've got the 4-year degree, but they CAN really do it!" Underburger retorted, "You can study

concrete for four years, but can you actually make concrete?"

Lines added, "Can you imagine the power lan's going to have when he takes Materials Science and Concrete Design, and he hears terminology like 'tarantula curve' and thinks, 'I've done that before, this is old-hat!" In fact, Lines shared that many concepts Underburger has learned through NPCA's PQS-I class and on the job at ConSeal this summer may only be taught at the graduate level at some universities.

Ultimately, Underburger had been thinking about bridge work as a career, but after this summer's experience, he is open to the possibility of all facets of Civil Engineering.

### Internship Resources

The Southwestern Ohio Council for Higher Education (SOCHE) is a nonprofit consortium of 23 regional colleges and universities. In a typical

year, they have hundreds of students working across Southwestern Ohio <u>and other Ohio regions</u>. Learn more at: <a href="https://www.soche.org">https://www.soche.org</a>. Another option is to reach out to local colleges, trade schools, and adult education centers and inquire about their internship programs. If they have none, start a dialogue with them about our industry.

### The NPCA Foundation Scholarship

For over 20 years, the National Precast Concrete Association Foundation has provided educational scholarships to undergraduate and graduate students enrolled in civil engineering, architectural, and construction-related curricula. Students can receive up to a total of \$14,500 over the course of their academic enrollment, providing they complete the PQS-1 class and fulfill an internship working at least 320 hours with an NPCA member company each summer of eligibility.

"NPCA Producer and Associate members can host interns," Lines said, "the work must be meaningful and industry-related so that the student intern can learn different facets of the business and see the career opportunities."

Lines serves on the NPCA Foundation Board and the Scholarship Selection Committee. He reported that this year, 11 new scholarships were awarded to students majoring not only in Civil and Structural Engineering, but also Business Administration. "Applicants don't have to be a Civil Engineering major to qualify for the scholarship," Lines explained, "their career path needs to be precast or construction industry-related; so, for example, the recipient majoring in Business has family in the precast industry, and the student's career goal is to help manage the company."
